CHURCH OF THE LATTER DAY SAINTS, BEAUFORT, SC

For several month at the end of last year I went through records filed in the LDS records in Salt Lake City, using the facilities of the Family History Center in the LDS church in Beaufort, SC, 29 miles from our old.house and now about 19 miles away. Two microfilms seemed of special interest. The first was CALL NUMBER, USA/CAN, FILM AREA, 1032586, Item 1. The title was Swetland/Outman family papers. The contents were:

Contains S. K. Stevens account book, 1873; S. K. Stevens Justice of the Peace docket book from Potter County, Pennsylvania, 1875-1885; and genealogical papers of Lena E. Stevens with family data of the Stevens, Swetland and Watrous families of Pennsylvania.

I went through this eagerly as I knew who Lena Stevens was. She was the genealogist who sent my grandfather much data he compiled in papers left to me. Another thrill came when I read that this material was only part of Lene Stevens records and the balance was filed with the Pennsylvania State Archives in Harrisburg, PA. Somehow I must go to Harrisburg to look up these papers.

The second microfilm was CALL NUMBER, USA/CAN, FILM AREA, 1035549, Item 3.

AUTHOR, Sweetland, Leon Hiram, 1904-0000 (ed: still alive when microfilmed)

TITLE, Sweetland family genealogy, Leon Hiram Sweetland and Emily Esther Sweetland Putnam.

CONTENTS Includes ancestry of Leon Hiram Sweetland (b. 1880) through William Albert Sweetland (b. 1845) and Celestia Miranda McNall to John Sweetland/Sweatland/Swetland (1603-1685) and his wife, Suzanna Temperance, whose family immigrated from England and settled in Massachusetts. Descendants include Mormons. Includes variant spellings, Sweetland and Swetland as well as Bradford, Brewster, Putnam, Warren and related families.

Many of us who attended the third reunion in Wilkes-Barre, PA will remember Ruth Sweetland and Emily Putnam giving a joint talk on their ancestry, the common ancestry and the differences. Of note from the microfilm is the fact that all of Leon Hiram Sweetland's files have been saved by his grandson, Leon Hiram Sweetland, III who lives in Evergreen, Colorado.

I have made photocopies of many pages from both microfilms and expect to bring them to the 1997 reunion. I will be sure to have them on Friday afternoon for our genealogy discussions. By the time we leave Bluffton, I will surely have opened the mystery box which contains these photocopies so I can bring them. Wish me good luck and the best to all of you till we meet.
