Dear SFA Member:

# Benjamin Swetland, the Fife Major

Benjamin Swetland descends from William and Agnes Swetland of Salem, MA. His father was John Swetland, Jr., and his grandfather was John Swetland, son of William and Agnes. Benjamin was born September 29, 1856 in Bolton, CT and died September 29, 1819 in Waterville, NY. On June 6, 1782 he married Rosanna Hancock in Springfield, MA. Rosanna, daughter of Silas Hancock and Rachel Wright, was born August 4, 1763 in Longmeadow, MA and died June 15, 1838, also in Waterville.

Benjamin Swetland enlisted May 1, 1777 and served in the Continental Army in the third Massachusetts Regiment under the command of Col. John Greaton in Capt. Charles Colton's company. Benjamin kept the roster of the company and used his book during the war for notes, military orders, speeches, ciphers, Bible verses and hymns. He also used his book to write births, deaths, and other family information. He was 20 years old when he enlisted the first time 'to do or die for his country' as he once wrote. Here are some entries from the roster which he kept:

"Appointed May 1, 1777 Fife Major, Benjamin Swetland.

His weekly return of February 24, 1780 is signed "Benjamin Swetland, Sargt."

"A short account of three year's campaign. On May 1, 1777 I enlisted under the command of Capt. John Greaton of Roxbury, MA in Capt. Charles Colton Company of Springfield until the August to guard Continental stores, and then received orders to join the Regiment which we found at Van Sloik's Island near Halfmoon, then from there to Stillwater, then after the battles, then Saratoga wheare Burgoine surrendered with his army to the Americans.

"WestPoint, October 17th: For

years from this day since the surrender of Genl. Burgoin at Saratoga in the year 1777, Benjamin Swetland, Eye witness,

"Sunday, April 30, 1780 at Continental Village: "I got my discharge from the service of the United State of America and came as far as Crompound and tarried there till Wensday, the 3rd of May, and then I set out and came to Salem that day, and the next day I came to Woodbury and there I staid until Monday, the 8th of May, and then I set out from Woodbury and came to Southington, and the next day I arrived at Hartford, Friday, May the 9th, 1780.

While in service he was promoted to Fife Major (Fife and Drum Corps) and then Seargeant. After his discharge in April,. he re-enlisted August 23, 1780 at West Point in Captain Cook's Company, Col. Canfield's Regiment of the Militia and was discharged in 1781. He is listed in the DAR Patriot Index, Copyright 1994, Page 2868, DrmFifMaj, PNSR. He was pensioned, Act of 1818 (Pension R 10355V) but Rosanna's widow's pension was rejected because she was not married at the time of his service in the War (they were married in 1782.)

Benjamin along with his daughter. Florilla, was featured in a 7 page biography (with photos of his musket, which he carried with him throughout the war, and his warming pan, plus pages of his roster and music) which was published in 1904 in a book entitled "Chapter Sketches-Connecticut Daughters of the American Revolution-Patriot's Daughters. At the time of the writing of this book, the musket and warming pan were owned by the William G. Mayer family, the Roster book was in the hands of Benjamin's grandson, William Wirt Smith, Esq. of Chicago, IL who later donated it to the Chicago Historical Society (about 1904).

His death is September 30, 1819 on his tombstone and September 29, 1819 in family sources.

Some of the data on this family is taken from DAR applications of family descendants.

Susan Hahn kindly sent other information on Benjamin. Her material included nine pages from the book mentioned above. Much of the data on the nine pages came from Benjamin's daughter, Florilla, who passed her 100th birthday about the time the book was published.

One of the nine pages shows a hymn written by Benjamin, entitled "A New Song." The words show his patriotic feeling. The hymn states that it was written in 1780 when he would have been about 24 years old.

Benjamin and his wife Rosanna had eleven children, three sons and eight daughters, of which Florilla was the ninth, born October 23, 1803 in Waterville, NY She married Reuben Pierce, a soldier of the War of 1812. Reuben and Florilla also had eleven children, five sons and six daughters.

This story on Benjamin Swetland will surprise Susan Hahn whose husband Brian is a direct descendant of Benjamin. Susan sent me the data November12, 2002. I misplaced the information and wrote Susan telling her I could not find it. She gave up on me and never responded.

With great care when I received the information from Susan, I placed her papers in protective sleeves and filed them in a new ½" binder which I stored above some genealogy binders on a bookshelf in the den. The new binder was not labeled. Not until three weeks ago did I look again at this binder. I was thrilled to see this data I never throw anything away but it can be difficult to find everything I want when I need specific material.

### Family History

A visit to The Peddie School over two years ago resulted in Dr. David Martin, the school archivist and a history teacher there, showing me a form submitted by an alumnae, Grace Swetland. Grace was the sister of our Gladys Swetland and the oldest of Chet and Kate Swetland's four children. Grace left Peddie in 1906 after graduating from the school. She attended Elmira College, Elmira, NY, 1908-09 and Michigan State college, Ypsilanti, MI, 1912-13. In her career she taught English and Latin at the Harrison High School, Harrison, Valley, PA and was Library Assistant and Assistant librarian at the Olean Public Library, Olean, NY and then worked in the Port Jarvis, NY, Port Jarvis Free Library. Grace was also the Postmaster in Mills, PA from 1941-1945. One never knows what new data will turn up.

### **Family Associations**

The Swetland family Association has existed since 1986, the year of the first reunion. Imagine having existed for 137 years. The Kelloch family began their reunions in 1867 and are still going strong. Their reunions have had between 69 and 200 attend their gatherings. They meet every year at the ancestral home in Warren, ME where a Scot, Finley Kelloch, settled. Some members come every year. One member of the Kelloch clan has attended 95 of their reunions. She is now 101 years old. Does anyone believe that our association can equal theirs?

### **Our Own Website**

At the two most recent reunions the subject of a family website came up. A member at each reunion offered to set one up and run it. And each time work and other activities prevented this from happening. Do we have enough need for a website for someone to set up a Swetland Family website or similar name?

Here at Sun City Hilton Head several friends have set up personal websites. Cost seems to be nominal but I have no recent figures.

Two of our members have websites using MyFamily.com. Costs would be free for a 30-day trial. A Standard Site costs \$29.95 a year and a Super Site with Personal Domain costs \$109.95 a year.

If we were to set up our site with MyFamily.com, a yearly cost of \$29.95 seems reasonable. A major question is who would set this up and run it Keeping a website interesting takes time and effort so that members will use it. Another source suggest that a site needs 10 to 20 regular visitors to be useful.

If enough comments come back either for or against our personal website, we can decide whether to look further into a family website.

What are some of the reasons to join MyFamily.com? We will have an online home. The site ensures privacy since it will be password protected. It will be easy to communicate with each other and share pictures, video and voice clips. We can stay current with address

changes. MyFamily Message Boards will enable us to exchange views, questions and suggestions on hundreds of topics. It will save money if we should want to contact members overseas and we do have one in Australia who contributed a great story of Sweetlands in Australia.

MyFamily.com is also a way to create a family tree, save stories and record dates.

Important questions are will enough members use it and who will run the website. Since I stick my neck out often, I offer to set up the website with MyFamily.com if members feel that the yearly cost is within our resources and enough of us want to use a family website. Without use and contributions of data we have no need for a website.
