No one would have predicted in 1986 that I would be writing or even living in June 2007. I passed my 85th birthday last August 15th. It is now time for another SFA member to produce S/S Lore in future years.

Please realize that if no one steps forward to be the editor, you are reading the final issue of S/S Lore. I have produced 60 issues since the first in early 1987. Are you willing to see this newsletter disappear? If only I had the energy and health to produce S/S Lore a few years more! Regrettably I recognize that I cannot continue as editor. If you take over, you will be the glue that holds us together.

### **Another Swetland Earns a Patent**

It may come as no surprise to many of you that Sw(e)e(a)tlands are industrious folk. And once a Sw (e)e(a)tland gets his or her mind set on something, it is hard to deter them from it. So it is that several Sw(e)e(a)tlands have made their mark on the world and possibly on your life as well.

In 1923 Ernest John Sweetland patented the first replaceable automobile oil filter. He had set his mind to find a better and easier way to filter the oil in the new automobiles that were emerging. He recognized the need for the filtration of the oil from all the dust and dirt they kicked up. Remember they did not have asphalt roads then. His wife would ask him to separate himself from his work and go on a picnic with the family. However, whilst driving to a nice location for a picnic, Ernest would be thinking about his oil, even to the point of changing the oil and inspecting it while his family frolicked at the picnic. He did discover what he found to be an easier and better solution. He nicknamed it Purolator, from the words "Pure-oil-later." Ernst licensed his patent to the Motor Improvements Company in NY which later renamed the company to Purolator Products Inc. These filters quickly became standard on all automobiles built by Chrysler, and later on by a variety of other auto and tractor manufacturers as well See more at http://www.pureoil.com/ and then click on Company Info and then History.

In 1999 Byron Swetland and his wife Melody patented a bubble solution that glows under UV or "black light." The intent of these bubbles is for entertainment and decoration. Byron and his wife experimented at home trying to come up with the right solution. Byron is not a chemist and never went to college. But once he had the idea in his head, he stayed hot on the course. His bubble solution is so unique that several large industrial chemical companies applauded him for his discovering the right solution when they and their chemists could not. Now one more has laid claim to a US patent, Jamie R. Swetland. His patent is for a Vertical Justification System for mail handling automation. As always, there is more than one way to solve a problem. Some are more complex and some are more simple. Jamie's patent takes the simple approach. The general problem is in automaton equipment designed to separate, transport and sort flat articles such as letter mail, magazine mail, and more, these can become skewed or ride high in the transport. This makes it difficult to impossible for other systems of the machinery to detect, read, barcode, or even sort these mail pieces in this orientation. Jamie's solution employs a soft rubber wheel mounted at a slight downward angle. When articles pass by the wheel, it gives a downward nudge thereby leveling or correcting the orientation of the mail piece. You may never see this device but it could have an impact on how soon and in what condition you receive your mail. Jamie has recently submitted two more patent inventions for patent review. It takes several years for the whole patent process to be complete but you may be seeing more patents with Jamie's name associated with them and a potential impact on your life. #### **Fundraising Trip to Africa**

Mark Harrison has told me about a trip that Carroll Wilcox, a co-worker of his, plans to take next year. Carroll has already made a commitment to climb Mt. Kilimanjaro at the end of February 2008. Each climber, in addition to the base cost, is to raise \$2500 in donations for the American Cancer Society. With the climb at the end of February 2008 they have less than a year now to raise the funds.

The goal is to raise \$100,000 by the entire group. In addition to individual fundraising efforts, the ACS hopes to have one minor and one major fundraising event each month for the remainder of the year for which they will sell tickets or something depending on the nature of the event.

When Carroll wrote, they al-

ready had 25 people including Carroll who have signed up to climb Mt. Kilimanjaro. In addition another 12 interested people are not yet signed up. Carroll's picture is already on the website under Meet Those Who Are Involved.

Carroll adds that any amount short of his obligation of \$2500 has to come out of his pocket so he is understandably motivated to lessen that number.
